



SITE SAFETY PRACTITIONER AWARD 2019

1. The Process

Site Safety Practitioners working in the Hong Kong Construction Industry are invited to enter the Site Safety Practitioner Award. These individuals will be senior frontline safety personnel working on construction sites in Hong Kong and may include: senior safety officers, safety managers etc.

The candidate shall submit the 'Entry Form', including a referee's statement and attaching requested documentary evidence.

The Award Committee will shortlist candidates for the final round assessment which comprises the attending of an interview and, for the finalists a visit to their workplace by a nominated inspector. The final decision will be made by the Awards Committee and endorsed by the Lighthouse Club Safety Committee. The Award will be announced, and presented, at the Lighthouse Club Contractors' Dinner, scheduled for 20th September 2019.

2. Basic Requirements of Candidate for the Nomination

The candidate shall...

- Be a Registered Safety Officer or Chartered Safety Professional or Equivalent
- Have 5 years post-qualification experience in health and safety
- Have 3 years working experience in the Hong Kong construction industry
- Be currently employed in the Hong Kong construction industry.

3. The Application

The deadline for submitting the application and all supporting documentation is **2nd August 2019** to the Lighthouse Club Hong Kong (email: info@lighthouseclubhk.com). The deadline may be extended at the discretion of the Award Committee.

4. The Award Committee

The Award Committee comprises members of the Lighthouse Club Safety Committee, the Society of Registered Safety Officers and Hong Kong Occupation Safety and Health Association.

5. Short-listing of Candidates

Up to 10 candidates will be short-listed for an initial interview by members of the Awards Committee. Based on the initial interview 5 finalists will be chosen and inspections of their place of work arranged by representatives of the Awards Committee. The finalists may be required to attend a 2nd interview at the discretion of the Awards Committee. The Awards Committee will propose the final results to the Lighthouse Club Hong Kong Safety Committee for approval.

6. The Award

All top prizes winners will receive a trophy and a certificate.

7. The Award Ceremony

The presentation of the Site Safety Practitioner Award 2019 will take place at the Contractors' Dinner on 20th September 2019. Main Contractors, Subcontractors and many other related organizations will be invited to attend.
